I refer to your request dated 25 July 2022 made under the Freedom of Information Act 2014 for records held by the Health Information and Quality Authority (HIQA).

Your request was the following:

The papers outlining the implications for Hiqa as a result of the Ukraine crisis, presented at the board meetings from March until July 2022.

I have now made a final decision to grant your request on 29 July 2022.
